Report details:

- published in 2010
- pdf has 8 pages
- report had no chapters or sections dedicated to history
- according to NVivo's text search, the word history (using stems) is referenced 3 times, representing 0.60% coverage
- after deleting references from the bibliography, notes or headers, there are **2 references** to history in the content of the report
- history discussed in terms of uncovering and learning from the past

History is referenced in the report in the following ways:

- need to reveal history in order to heal society and learn from the past
- it is crucial that civic groups and not governments take the role of dealing with the past
- there is a need to re-write South Korea's modern history

History and truth are discussed in the following ways:
